If you're late telling us about your liability to register for VAT or if you delay in charging VAT, you must still pay arrears of VAT.

You must start keeping records and account for VAT from the date when you were required to register, even if you have not received your VAT registration number and certificate. But you must not show VAT on any invoices you issue to your customers until you have your VAT registration number.
